OUR STAFF IS BASED FULL-TIME IN THE SCHOOL, PROVIDING INDIVIDUAL AND GROUP COUNSELING, CLASSROOM INTERVENTIONS, CASE MANAGEMENT, AND HOME VISITS - ALL GROUNDED IN SOCIAL-EMOTIONAL LEARNING (SEL) AND TRAUMA-INFORMED CARE. OUR PROGRAMS INCREASE STUDENT WELLNESS, ATTENDANCE, ON-TASK BEHAVIOR, AND ACHIEVEMENT LEVELS; IMPROVE TEACHERS' CLASSROOM MANAGEMENT SKILLS AND INCREASE THEIR TIME SPENT ON INSTRUCTION; REDUCE VIOLENCE AND SUSPENSIONS; ENGAGE PARENTS AND FAMILIES; AND ULTIMATELY CHANGE THE CULTURE OF THE SCHOOL.
